#### Past Events

Annual Academic Council, Tajikistan, 30 May 2019



Prof Shahidi gave a talk at the Annual Academic Council. The presentation was based on results of her participation in Brussels/European Parliament and the London Forum organised within the GCRF COMPASS Project. She discussed the importance of the project and the benefits of cooperation with the UK. The capacity-building need for exchanging knowledge and ideas with UK academics and partner countries was highlighted during the forums, and Prof Shahidi commented on organising an event of the similar significance in Tajikistan as part of the project.

# 10-year anniversary of the Eastern Partnership Initiative, Brussels, 14 May 2019

Prof Korosteleva was invited to a highlevel ministerial meeting in Brussels for the celebration of the 10-year anniversary of the Eastern Partnership Initiative (#EaP10) and discussions of its future for the neighbourhood. The meeting was opened by President of the European Commission Jean-Claude Juncker, who noted the EaP's strategic importance and many achievements. HRVP Federica Mogherini underscored the people's factor, which she was sure would drive the policy success forward. Ideas for greater EaP visibility, AA+, transport and energy connectivity, and tailored partnerships will be defining the EaP's future direction. Resilience governance will stay firmly on the agenda of the EU strategy towards the Eastern region and Central Asia.



Weekly meetings of Tajik team in TNU in the framework of the COMPASS project, 13 May 2019

Prof Shahidi presented her report on the GCRF COMPASS Cambridge organised 'Research in Action' workshop in Bukhara 8-11 April 2019 to the Academic Council of the Faculty of International Relations of TNU. In addition presentations by participants on their knowledge and impressions from the trip were discussed, as an example of how to proceed in Tajikistan. At the end of the meeting, the role of each member of the team in the implementation of further plans within the framework of the COMPASS project was defined.

#### GCRF COMPASS LANDMARK EVENT - International Student Convention held in the BSU on 25-27 April, 2019



GCRF COMPASS Student Convention titled "Integration of integrations: status quo, challenges and perspectives" was held in Minsk as part of the 76th BSU Annual Students Scientific Conference. Forum gathered over 800 participants including 30 representatives (students and junior researchers) from all COMPASS partner universities - Kent, Cambridge, UWED, TNU, BSU, and Giessen (Germany) separately. At the opening session on April 25th, participants were welcomed by HE Ms Fionna Gibb, British Ambassador to Belarus, Prof Korosteleva, Prof Shadurski, Dean of the BSU Faculty of International Relations and Dr Nazaranka. The plenary session included report by UWED students S. Yodgorov and O.Akromov on Uzbekistan's New Foreign & Regional Policy. Young researchers presented and discussed their research findings in three panels -Integration initiatives in wider Eurasia, European Integration Project, Conceptualizing "Integration Integrations"; followed by intense Q&A. Students launched their 1st Student Forum (with a blog to follow), WhatsApp communication page, and visited many historic and cultural places in Minsk, including the National Library, WWII Museum, and the Bolshoi Theatre.

COMPASS Cambridge-led 'Research in Action' Training Workshop in Bukhara, Uzbekistan, 8-11 April 2019



GCRF COMPASS Cambridge together with the Coordination and Methodological Centre on contemporary history under the Uzbekistan Academy of Sciences organised a three day workshop entitled 'Research in Action' on 8-11 April 2019. It was designed to engage with varied research cultures, interdisciplinary research, and methodologies of research while considering the most current concerns in Central Asia, wider Eurasia and globally. It was organised with support from the Embassy of Uzbekistan in the UK, Academy of Sciences of Uzbekistan, the Academy of the General Prosecutor's Office of Uzbekistan, and the Institute of Contemporary History under the Academy of Sciences in Uzbekistan, University of World Economy and Diplomacy. This workshop provided the basis for research capacity building, a core goal of the COMPASS project, in academia, government and media. The workshop focused research methodologies development across and encompassed paradigms sustainability, multilateralism, scientific and cultural diplomacy, international relations, political economy, industrial policy and technology, science and education amongst other areas.

#### Visit of Baroness Suttie to Belarusian State University, Minsk, 8 - 9 April 2019

Member of GCRF COMPASS Advisory Board Baroness Suttie visited the Belarusian State University on 8-9 April, 2019. Baroness Suttie met with BSU Rector Professor Andrei Karol and other members of the university leadership on the 8th of April to discuss the implementation of the COMPASS project at BSU and broader perspectives of Belarusian-British cooperation education and science. She delivered a public lecture attended by over 150 BSU students and academic staff members on "Brexit and new global challenges" with an extremely intense session of Q&A. She ran a training session on British Parliamentary Debate for members of the

BSU Students Debating society, adjudicated a game on EU-related topics and shared valuable advice on preparing for public debating.



On April 9th, Baroness Suttie, accompanied by Belarus NTL Artsiom Nazaranka and Prof. Victor Shadurski visited the Upper House of the Belarusian Parliament where she met with Prof. Oleg Rummo, head of the working group of the Belarus National Assembly on cooperation with the British Parliament.

Regional Seminar for Heads of Delegations and the EEAS, College of Europe, Natolin, 28 March 2019



Prof Korosteleva was invited to speak about the current developments in wider Eurasia at the Regional Seminar for the Heads of EU Delegations and the EEAS at the College of Europe Natolin. The seminar was attended by all EU Delegation Ambassadors, EU Special Representatives to the region and senior representatives of the EEAS, Commission and EU Chief BREXIT Negotiator Michel Barnier.

#### GCRF COMPASS Workshop on BRI in Kent and Cambridge 13-15 March, 2019

On 13th March a one-day workshop took place at the University of Kent, Canterbury. The workshop entitled, 'The Belt and Road Initiative @ Five: Taking stock of global ambitions, regional response, and looking ahead,' brought together scholars working on recent developments regarding China's BRI and the regional responses from Eastern Europe and Central Asia to China's

growing investments. The workshop hosted three panels, on China's grand strategy and its visions for international order; and on regional responses to the BRI, focusing particularly on the Eastern neighbourhood and Central Asia. The workshop was followed by a Master Class on 14th March where postgraduate students at the University of Kent took the opportunity to ask questions about the BRI to the experts participating in the workshop: Prof Aleksandr Baichorov (BSU), Prof Kerry Brown (KCL), Dr Olivia Cheung (Warwick) and Dr Alice Ekman (IFRI). Students asked among others about the impact of the BRI on relations with Europe and the USA; the economic and security implications of the BRI; and the legal context of these developments.



Following the workshop in Kent, GCRF COMPASS Cambridge organised a one day workshop on 'BRI and the Silk Road' on 15 March in the Centre of Development Studies. This workshop was a continuation of the workshop on BRI organised in the University of Kent by our GCRF COMPASS partners in Kent. The workshop included presentations and talks by Prof Peter Nolan, Dr Sanghera (Kent), Dr Radivojevic (UCL), Dr Satybaldieva (Kent), Dr Kudaibergenova (Cambridge), Dr Safdar (Cambridge), Prof Baichorov (BSU) and P. Kalra (Cambridge). The workshop was moderated by Dr Saxena.



Certificate Programme on Combatting Human Trafficking, ADA University, 11-13 March 2109

On March 11-13, ADA University has conducted certificate program on

"Enhancement of National Capacities to Combat Human Trafficking in Azerbaijan (ENCT)" in partnership with European Union and international organization for Migration (IOM). In this 3-day long training for students of diplomacy and international relations program of ADA University have been encompassed capacity building of future diplomats in the field of combating human trafficking, key concepts and action procedures to take relevant actions to combat human trafficking and assist victims of trafficking (VoTs).



Roundtable on Dynamics and Dynamisms of the Emerging Global Order, University of Cambridge, 8 March 2019



GCRF COMPASS in collaboration with Centre of Development Studies, Cambridge Central Asia Forum and Jesus organised Strategic College a Ambassadorial meeting on 8 March 2019. The panel consisted of HE Jawad (Ambassador of Afghanistan), Khalifzoda (Ambassador of Tajikistan), Shavkhov (Ambassador Uzbekistan), Mr Annayev (Embassy of Turkmenistan), and Mr Sydykov (Embassy of Kyrgyz Republic). Senior Cambridge academics like Prof Lord Mair, Prof Nolan and Mr Ray were also part of the panel with Prof Shahidi (TNU) and Prof Korosteleva (Kent). The meeting was chaired by Dr Saxena and attended by students, early career researchers and colleagues from University of Cambridge. The roundtable was followed by a cultural evening to celebrate Navroz (New Year). This momentous occasion was especially

important since it coincided with International Women's Day. The evening showcased the wonderful varieties of dance, music and cultural experiences that Central Asia and wider Eurasia has to offer. The audience (200+) was enthralled with the beauty and grace of children, men and women representing their countries in the oldest chapel in Cambridge.

International academic conference on 'The role of university education and science in modern society', Minsk, February 26-27, 2019

The conference was timed to coincide with the 100th anniversary of the adoption of the Soviet Belarus Government Decree of February 25, 1919 to open a University in Minsk. The opening speech was delivered by the BSU Rector Professor Karol. The plenary session talks by leading BSU academics (Prof O. Yanovski, Prof G. Vasilevich, and Prof V. Shadurski). Prof Marzalyuk, Chair of the Standing Commission on Education, Culture and Science of the House of Representatives of the National Assembly of the Republic of Belarus also gave a talk. The event attracted over 170 researchers from Belarus, Russia, Poland, Germany, Slovakia and Turkey. During breakout sessions participants discussed the university achievements in research, educational and cultural fields, the role and place of the university in the global academic community, and future development strategies.



Early Career Researchers Training School, ADA University, 25 February -1 March, 2019



ADA University Center of Excellence in EU Studies conducted its 1st Early Career Researcher Training School on Research Methodology within the framework of the COMPASS. dialogue, Cambridge parliamentary hosted Parliamentarians from the Kyrgyz Republic, Kanybek Imanaliev, Vice-Chairman of Committee on the international affairs of Parliament of the Kyrgyz Republic, and Sadyk Sher-Niyaz, Deputy of the Kyrgyz Parliament; Chairman of the Commission on Social, Cultural and Humanitarian Issues of the Parliamentary Assembly of Turkicspeaking States (TurkPA).accompanied by Her Excellency Iskakova, Ambassador of the Kyrgyz Republic. The discussion covered the Central Asian regional political landscape, regional dialogues, BRI and EAEU.



#### Talk by Anisa Heritage and Pak K. Lee on 'China's Belt and Road Initiative and Counterhegemony', University of Kent, 10 May 2019

Anisa Heritage and Pak K. Lee (Kent) presented a paper titled 'China's Belt and Road Initiative and Counter-hegemon'. The paper focuses on the bilateral China-Pakistan Economic Corridor (CPEC), portrayed as the flagship project of the BRI, and Italy's signing up to the BRI in March 2019. Using the neo-Gramscian perspective, the paper reflects on how far China is able to espouse its own norms, rules and practices as part of a strategy to reshape the normative contours of global trade and investment.



Talk by Dr O' Connor (UCL, UK) on 'Dushanbe: old or new? A city beyond its borders,' University of Cambridge, 3 May 2019



Dr O'Connor explored the lives of cultural producers, or intelligentsia, of Dushanbe, Tajikistan in the talk. By tracing the lives of multiple generations of artists and scholars, this project aims to reflect on how ideas and artistic/literary movements were produced, used, shared and transformed during Tajikistan's fastchanging history. The research focuses on the longue durée of knowledge production and social consciousness over the past century with the arrival and collapse of Communism and the following 25 years of national independence. The lives, ambitions and projects of Tajik cultural producers highlight the successes and failures of Soviet ideology, and the varied and conflicting frameworks of social change that different social groups and generations of people think and work within. By engaging with Dushanbe and its cultural elite Dr O'Connor provided a snapshot of the importance of an understanding of layered identity in the context of Central Asia.

#### Conference on Connecting Central Asia in the 21st Century', University of Oxford, 25-26 April 2019

GCRF COMPASS participated in a student-organised multidisciplinary conference 'Connecting Central Asia in the 21st Century' on 25-26 April 2019 organised by the Russian and East European Studies Programme of Oxford University's School of Global and Area Studies. C. Laumulin (University of Cambridge) and Dr Umarov (UWED) participated in the event which brought together leading scholars and researchers united by their interest in Central Asia's past, present and future. C. Laumulin presented a paper on science and technology and considered aspects of a development paradigm in Central Asia based on regional requirements. He

presented his work in the panel entitled, How Does Central Asia's Past Create Its Present?' chaired by acclaimed author and academic Prof Frankopan.



Dr Umarov presented his understanding of the Belt and Road Initiative's perception in Central Asia on the panel entitled, 'Belt and Road Initiative—Regional Boom or Bust?'. He shared his views on the transformative impact of the BRI projects for Central Asia, the influence of the BRI on economic growth strategies, possible opportunities and challenges, and the importance of the increased connectivity for more effective regionalism in Central Asia.

# 'Cultural Diplomacy in Central Asia', Workshop in TNU, dates

COMPASS-TNU team in collaboration with the Republic of Tajikistan Centre of Strategic Studies, Academy of Sciences of the Republic of Tajikistan and Shahidi International Foundation focuses on the development and discussion on what is the nature of cultural diplomacy in the region, how research integration of the near past has been highlighting the common regional interconnection in the wider world historically and in present day through the means of local/regional/global cultures. Through the followers of that interconnection are widespread to-day, we aim to unpack the notion of "culture" – the

binding and meaning-making, valueproducing part of every society and study how cultural diplomacy influences the development of networks, relationships and inter-state institutions and agreements.

#### **Awarded Grants**

Dr Saxena and P. Kalra (University of Cambridge) in collaboration with Prof Shin (Hanyang University, South Korea), Prof Dzarasov (Central Institute of Economics and Mathematics of the Russian Academy of Sciences) and Dr Muratbekova (Eurasian Research Institute, Almaty, Kazakhstan) won the prestigious Global Research Network Grant from the Korean National Research Foundation for 2019-2021 for research on 'History of Eurasian Knowledge and Science Network in Evolution of Eurasian and Regional Integration'. The research aims at finding a constructive and mutually-beneficial way for using science-technology diplomacy for South Korea and Eurasia that would maximize both the potential of Eurasia and its cooperation with South Korea.
