

Overview for managers of annual leave, absence management and TOIL

Since January 2019, Staff Connect is the only recognised University record for all absences. Staff Connect has been designed to reflect our existing absence and leave management policies, which can be found [here](#). This guide is designed to provide you with additional information on the different types of absence being recorded in Staff Connect. You may also find the [Staff Connect FAQs](#) and step-by-step [user guides](#) are helpful.

All absences are recorded in Staff Connect in *hours*, not days. Please be aware that Staff Connect calculates a default work pattern for everyone by averaging the number of contract hours over the number of working days. Many staff do not work the same number of hours on each day and therefore there is a facility to override the hours for any day, to ensure that the correct, actual number of hours are booked as leave/sickness absence etc. If the number of working days is incorrect, then please contact the appropriate HR Operations Team.

Annual Leave [Policy](#)

All members of staff are given an entitlement based on their conditions of service. All periods of annual leave must be recorded on Staff Connect to ensure your team are taking their entitlement. The annual leave year starts on 1st January when your team are given their new annual entitlements, which will include entitlement for Bank Holidays and Customary Days. Please refer to the relevant conditions of service to see how leave is managed for different groups of staff and refer to an individual's contract to ascertain their actual leave entitlement. Your members of staff can enter their annual leave as a request which will be sent to you for approval, or you can enter annual leave on behalf of your team.

Academic and research staff in grades 7 and above do not have a prescribed annual leave entitlement and the norm is that they take all their holiday outside of term time, therefore there is no express requirement for annual leave to be recorded in Staff Connect for this staff group. However, the law requires that all staff take a minimum number of holidays each year and it is good practice to record this. Therefore, we have created a 'notional' entitlement for academic and research staff to facilitate the recording of their leave, if desired.

The system will calculate any carry over entitlement automatically. This will be calculated by your total leave entitlement, minus the number of hours annual leave you have taken in that year. The system will only be able to carry over up to the maximum permitted hours into the next year. For this reason, it is important that all annual leave is logged correctly.

Bank holidays and customary days: For full-time staff, bank holidays and customary days are automatically deducted; for part-time staff a holiday booking needs to be made in order to ensure the correct number of hours are deducted. You and your members of staff are responsible for correctly recording and managing Bank and Customary days.

Sickness

Policy

All periods of sickness absence for all staff - including academic and research staff – must be recorded in Staff Connect. Please refer to the sickness absence [Policy](#) and [Procedures](#) for full details on sick pay and managing sickness absence. Staff can enter their own sick leave which will be sent to you for authorisation, or you can enter sick leave on behalf of your staff.

The Sickness Absence/Self-Certificate has been replaced by the data fields on the Staff Connect absence record page, so the paper form is no longer required. Paper based sickness forms submitted to payroll for new periods of absence from 02/01/2019 will be returned and you will be asked to enter the sickness on Staff Connect. For long term absences Payroll will continue to manage these until the absence ends after which you will need to send a form to payroll to close it down.

The Return to Work interview form will be available via a link in the Absence module for you to complete electronically and upload to Staff Connect.

Med3 / Sick / Fit notes must be scanned and uploaded to Staff Connect to enable the Pay Office to process the absence correctly.

Time off in lieu (TOIL)

Paid TOIL on an hour-for-hour basis can be awarded to those who are contractually obliged to work a prescribed number of hours per week. The decision whether to offer time off in lieu will be made by the responsible supervisor and will be communicated to the member of staff before the work is undertaken. The taking of TOIL leave must be mutually agreed between the member of staff concerned and the responsible supervisor.

TOIL balances in Staff Connect are kept separate from annual leave entitlements. For Staff in grades 1-6 TOIL can be earned by the hour. For Staff in grades 7 and above, TOIL is an informal non contractual arrangement but may be accrued, by exception, only in half day or full day blocks and where pre-agreed.

For all staff TOIL should be taken in half day or full day blocks.

In the case of grades 1-6 if a staff member with an outstanding TOIL balance changes post or leaves the employment of the University of Kent, they should speak to their line manager to arrange to reclaim this TOIL. If the TOIL cannot be taken then the department if they wish may choose to pay this TOIL balance as overtime. There is no corresponding entitlement for grades 7+”
