1. Rationale for Amendment/s and Record of Discussion on School's Reflection on the Guidance Points																																																																																															
<p><i>Due to loss of staffing through KVSS as well as the restructuring of the EDA PG-T provisions, a number of level-7 modules will not be available in 2020-21 (and onwards). This necessitates the change in the provision of optional modules in stage-4 of the MEng (CSE) program (see below). No originally compulsory modules have been withdrawn. However, the Optional module available for this stage has been amended (EL822, EL857, EL871, EL893 are withdrawn and are substituted by EL827, EL875). It is proposed that EL896 become compulsory (originally an Option) in this revised version.</i></p>

1.	<p>Rationale for Amendment/s and Record of Discussion on School's Reflection on the Guidance Points</p> <p><i>Due to loss of staffing through KVSS as well as the restructuring of the EDA PG-T provisions, a number of level-7 modules will not be available in 2020-21 (and onwards). This necessitates the change in the provisions of optional modules in stage-4 of the MEng (ECE) program.</i></p> <p><i>No originally compulsory modules have been withdrawn. In the original provision, students needed to choose their options from a set of clusters of modules. Due to resting of the PG-T modules, only cluster-A is available. EL896 has been included instead of EL893.
